

# The Secretary of State's Offices May Be Closed, but CFSC is Open With Complete Auto and License Services

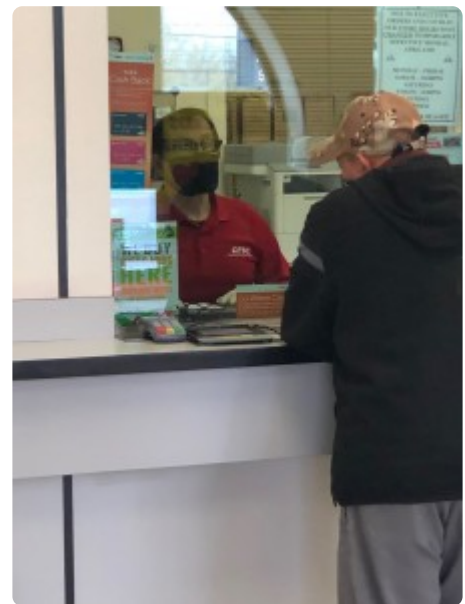
Focused on safety, convenience and flexible hours, Community Financial Service Centers remain open, offering complete auto and license services, many of which are completed in just five to seven minutes.
